






### Relevance to what I'm doing // Pertinence par rapport à ce que je fais

The food served was tasty but lots of carbs and no diet beverage. Would be nice to have two lines so food is served faster.

The conference attendance was skewed heavily toward older, white, male people. I feel we would have benefitted from more "norm-setting" at the beginning of the conference to help balance our conversations better. In many instances, I felt that the discussions were dominated by these identities, and their analysis of the work did not always include elements of race or gender. Often there was no recognition of how that privilege colors our

experiences, and the larger power dynamics at play there. As a young woman from a nonwhite background, I did not feel particularly well-represented in these conversations, nor was I always totally comfortable speaking up.

Moderators might wish to establish the ground rules for "Blue Sky" sessions as I found people were willing to argue points in the process of Blue Skying which is not effective to uncover all available ideas.

Good discussions and ideas. I enjoyed learning about how Spain was able to work toward pro public water services


Food: Placement of Vegan offering away from rest of food was discriminatory. I know you probably didn't want non-vegans to deplete supplies before vegans got to them.

The Open Format sessions only worked in a few cases. I've seen them work much better but some of the leads weren't embracing the process.





Make more of the public aware of the issues

Creating systems (that are built by and include all voices – not just elite, white, male voices) that allow for collaboration across industries and different geographic areas. From here, we find ways to channel seemingly disparate energies towards a collective fight, and unify towards an overarching "pro-public" narrative.

Establish the high ground not of morality but of effectiveness—work that benefits the most people. Explain the movement in a small chunk that seeks to respect rather than educate.

Have working groups plan to educate the public and lobby MP's for change

More meet ups and have regional meetings

Rallying and organizing at the local level.

Putting plans into action!

Did I hear that there are bills coming up in this fall's Parliamentary sessions for public banking?

If so, let's campaign legislators now to encourage greater support. Gov. change is notoriously slow, let's get momentum going beyond unions to give these bills more support!
